





2.User instruction

2.1 ON/OFF instruction

POWER ON: press "ON/OFF button for 3 seconds POWER OFF: press "ON/OFF button for 3 seconds and then press

"power off" on the screen.

2.2 Magnetic card

Put the magnetic card into the magnetic card slot to read, magnetic side towards the LCD (refer to the sign for card identification. keep smooth, uniform when swiping the card).

2.3 Contact IC card

Insert IC card into the IC card slot, the metal side towards keypad, please refer to card identification.

2.4 Contactless card

Put the contactless card near the contactless card reader zone on the device, and make contactless card transactions.

Put one contactless card every time to avoid conflict if putting more cards. 2.5 Charging

Connect the Type C cable to POS terminal, connect the other connector to 5V/2A power adaptor to charge.





4.Instructions for installation and usage

- 4.1 Please charge the terminal within the specified voltage range, don't use too low or too high voltage.
- 4.2 Please make sure the connection is correct when connecting the device to the host and/or the power adaptor.
- 4.3 Don't damage the cable, if the cable is damaged, do not use it anymore.
- 4.4 Don't expose the terminal with direct sunlight, high temperature, humidity, dusty or strong corrosive gas.
- 4.5 Stay away from liquid, don't use the product where the water may pour over or enter into, don't operate the product with wet hand.
- 4.6 It is strictly prohibited to open the terminal without permission, otherwise the terminal will fail, the consequence will be at your own risk.





- 4.7 Be sure to use the original battery or specified type of battery, otherwise it may cause the risk of explosion, prohibit the impact, extrusion, heating, short circuit or put the battery into the fire, the battery is prohibited to use after soaking.
- 4.8 Please follow step E to step K of Quick Installation Guide replacing the battery and remember to close the battery cover after replacing the battery.
- 4.9 Please refer step I of Quick Installation Guide replacing the IC Card,SIM Card T-Flash Card and PSAM Card.
- 4.10 Please refer step A to step D of Quick Installation Guide replacing printer paper roll.
- 4.11 Adapter shall be installed near the equipment and shall be easily accessible.
- 4.12 Here by, [VeriFone, Inc.] declares that the radio equipment type [Model: T650p Petro] is in compliance with Directive 2014/53/EU. The content text of the EU declaration of conformity is available on https://www.verifone.com/en/us/verifone-regulatory-and-compliance-sheets.
- 4.13 Please use Verifone verified power adaptor for battery charging; the temperature range under battery charging mode is 0 °C to 45 °C (Over Temperature protection 45 °C ± 3 °C, under Temperature protection 0 °C ± 3 °C). Do not operate and use the device outside the above temperature range, otherwise it may cause the risk of explosion.

5.Security provisions

5.1 Special conditions for safe use

- 5.1.1 WARNING DO NOT OPEN WHEN AN EXPLOSIVE ATMOSPHERE IS PRESENT
- 5.1.2 WARNING DO NOT CHARGE THE BATTERY IN HAZARDOUS LOCATION
- 5.1.3 WARNING USE ONLY SCUD SX18650-2S1PS 7.2V Li-ion Battery
- 5.1.4 The replacement procedure of battery pack shall be observed in line with Ex instruction.
- 5.1.5 Use only Ten Pao Electronics(Huizhou) model S010CNV0500200 (for EU version), S010CNS0500200(for AU version) and model S010CNU0500200(for NA version) AC Charger for charging purpose, if other charger used, then this charger must be approved by general industrial standards and has same output parameters as the approved chargers.
- 5.1.6 The POS terminal needs to protected from impacts with high impact energy.
- 5.1.7 The POS terminal are not permitted exposure to light for a long term directly, under the extreme situations, for example, the strong sunlight, the POS terminal should be used with additional protection.
- 5.1.8 It is not allowed connect the headset in hazardous area.
- 5.1.9 It is not allowed insert SIM card, T-Flash card and PSAM card in hazardous area. Additional temperature assessment and spark ignition assessment should be performed base on Type Examination Certificate if the unnormalized cards used.
- 5.1.10 It is not allowed replace the printing papers in hazardous area.

6.Fault identification and elimination

6.1 Cannot power on

Check whether the battery is out of power, plug in the power adapter to charge it. 6.2 POS does not work properly

- Long press the power on key to restart the terminal or plug in the battery.
- 6.3 Cannot print

Check whether the printing paper is missing and whether the paper cover is well closed.

*POS terminal is not allowed to be maintained by maintenance personnel not work with the company.

7.Password anti-peep instruction

- 7.1 Using body or hand to block when entering the password to prevent it from peeping.
- 7.2 The monitor range should be as far as possible from the placement of the terminal when installing the surveillance camera, so as to avoid the cardholder's password leakage.
- 7.3 Clients and merchants need to conduct routine inspection to ensure that the terminal has not been changed and there are no suspicious objects within the smart card and magnetic card slot.
